## 1. Brief Facts of the case:-

- 4.) It is requested that while replying please mention my letter No. date, your & 1<sup>st</sup> AA Email ID (LL) No. & 1<sup>st</sup> AA's official mobile No. if any."

2. Reply of CPIO:-

3. Ground of First Appeal:-

I have also not received to the point reply of any point of my RTI application. It is humbly prayed that I may be provided to the point reply of my RTI application.

## 4. Decision with reasons:-

The First Appeal, RTI application and reply given by CPIO of CIC have been perused. Accordingly, direction is being given to CPIO, (DR to IC VT) to revisit the matter and provide appropriate information point - wise within 10 days of receipt of this order.

- 5. The appeal is being disposed of accordingly.
- 6. In case the Appellant is aggrieved by the decision, he is free to file second appeal, if he so desires, before the Central Information Commission, Baba Gang Nath Marg, Munirka, New Delhi 110 067 against this order within 90 days.
