Sir,

Kindly, refer to your application dated 24.08.2015 diarized under diary No. 157972 on 02.09.2015. The information sought by you is as follow:

**Point No. 1**

- (a) Your complaint dated 06.04.2015 filed U/S 18(1) of the RTI Act was inadvertently registered as an appeal in file No. CIC/SH/A/2015/001212. As a normal practice, no feed back or comments of the Respondents are sought on the appeals registered by the Commission before the cases are fixed for hearing. The appeals are taken up for hearing in their own turn. In line with general practice, no feed back or comments were sought in respect of your complaint dated 06.04.2015.
- (b) In view of the position explained at point (a) above, providing of copies of the correspondence with the Respondents, does not arise.
- (c) The letter dated 14.02.2013 was issued from the earlier file No. CIC/VS/A/2012/000808 by the erstwhile Registry of Shri Vijay Sharma, no information is available with the Registry of Shri Sharat Sabharwal whether a follow up action on this letter was taken.
- (d) As already stated in reply to sub point (c ) above, no information in this regard is available with the present Registry of IC (SH).
- (e) Since the time slots indicated by you, i.e. “12.09.2015 or after 02.10.2015 and within October 2015” for hearing your appeal/complaint has already elapsed your query has become redundant. However, your Appeal/Complaint can be heard on priority basis in the category of ‘Sr. Citizen’ in case you make a formal request along with age proof of being so.

**Point No. 2.**

- (a) There is no “fast track system” in existence, presently, to process non-compliance cases. The action on the non-compliance cases is taken by the Registry of IC (SH) as and when such complaints are received.
- (b) Please, refer to the reply given at 2 (a) above.

**Point No. 3.**

These queries relate to M/o Defence and DoP & PW. As such, information relating to the point will be provided by the CPIOs of the concerned Registries to whom it is being forwarded.

2 Unfortunately, your application dated 24.08.2015 could not be responded to within the stipulated period as this was wrongly sent to the Registry of IC(SH) by Dak Receipt Section along with the routine dak meant for the Registry instead of forwarding it to the Nodal CPIO. Mistaking it to be a request for early hearing of the case, it was, inadvertently, placed in the relevant file. This unintentional error could be detected only when your 1<sup>st</sup> Appeal was received. The delay in responding to your application is sincerely regretted.
