Point No.: - 1

Asking reasons dehors section 2(f) of RTI Act, 2005. However, it is stated that you have already taken up the issue at various platforms including that before CCIC vide your compliant dated 05.07.2017 and 16.08.2017 which have been duly responded to by the Registrar, as per his letter dated 27.07.2017 and 30.08.2017 respectively, copies of which have also been enclosed by you as enclosure no. 1 & 6. As such, the issue has already been addressed and dealt in length. Furthermore, these facts have already been brought to your kind knowledge since long.

It may not be out of place to mentione here that <u>record in Central Registry is exclusively</u> <u>maintained on the basis of Dy. Nos. as such, what ever information undersigned CPIO provided, it was purely based on the basis of Dy. No. provided by the IC(Dak) & CPIO.</u>

Point No.: - 2

Asking reason dehors section 2(f) of RTI Act, 2005. However it is stated by perusing your communication dated 16.08.2017 that it was marked by the CCIC to the Registrar. Accordignly it was responded to by him.

Note:- Your allegation against the Ex. CIC (BS) & the undersigned CPIO are highly objected to and vehemently denied. It is highly unfair that the platform of RTI is being used in such a way. As such, you are humbly rewquested to kindly rerfrain yourself from such act hernceforth; otherwise, undersigned shall be constrained to initiate Civil/Criminal action against you for defamation at your risk and cost.
