Sir,

I am to refer to your RTI application dated 25-09-2017 received in the registry of IC-SA from RTI Cell on 03-10-2017 vide letter no. CICOM/R/2017/01228. The information sought is as under.

Point 1: While deciding the Second Appeal CIC/POSTS/A/2017/117352 filed by Sh. Choru Lal against Deptt. of Posts, the Commission in para-2 of its decision dated 06-09-2017 observed;

“The PIO stated that information has been furnished to the applicant in the instant matter as well as each RTI Application. He complaint that the appellant files 4 RTI's per week which is an obstruction to the regular course of work in the department.”

No information beyond this is available in the records. Moreover the CPIO cannot comment on observation of the Commission.

Point 2: A notice for hearing of appeal no. CIC/POSTS/A/2017/117352 was issued to appellant and Respondent CPIO through Video Conferencing. Sh. L.R. Parihar CPIO appeared in the hearing held on 05-09-2017. No information beyond this is available in the records.

Point 3: Same as in point-1.

Point 4: The appellant has sought views of the CPIO. Which is not an information.

Point 5: This point relates to Nodal Officer, RTI Cell. (*Transferred under sec. 6(3) of RTI Act*)

Point 6: File no. CIC/BS/A/2016/000240 does not relate to the registry of IC-SA. Further there is no decision dated 12-07-2017 referred to by the appellant against this file in Commissions website.

In case you are not satisfied with the information provided, you may prefer an appeal to the First Appellate Authority as per RTI Act, within 30 days receipt of this information/decision. Details of First Appellate Authority as given below:-
