Sir,

I am to refer to your RTI application dated 08.12.2017 which has been registered vide no. CICOM/R/2017/01478. It has been received through online RTI MIS in Central Registry on 15.12.2017.

Point wise reply to your RTI application dated 08.12.2017 is as under:-

1 to 3 For providing you the information, assistance was sought initially from the Registrar who is looking after larger bench cases (as the political party case is under the jurisdiction of Larger Bench of the Commission) vide letter dated 19.12.2017 while endorsing a copy to you.

The Registrar in turn vide his letter dated 21.12.2017 (received on 22.12.2017) requested undersigned to obtain the file in which said case was dealt with.

Since court cases are exclusively dealt with by the Legal Section of the Commission. As such further assistance was sought from the DS to Legal Section vide letter dated 22.12.2017. It has been replied to by the CPIO (Legal Cell) vide letter dated 03.01.2018. That 'information sought is not available in legal cell'. Accordingly requisite information to point No. 1 to 3 of your RTI application may be treated as Nil.

4 & 5 Concerned noting relating to issue no. 4 is running in two pages and concerned noting relating to issue no. 5 is running in 4 pages. A copy of each may be obtained by making a payment (@ Rs.2/- per page) vide DD/IPO in favor of PAO CAT, New Delhi or by cash in this office.

6 File is under submission for deciding the next date of hearing in the case.

7 The Registrar, custodian of information relating to Larger Bench cases in response to a separate RTI application (CICOM/R/2017/50817/1/CR1) remarked that the order of June, 2013 could not be implemented in view of reasons recorded in the order no. CIC/CC/C/2015/000182 dated 16.03.2015 passed by the Commission in the compliant for non-compliance of said case.
