The CPIO who has been allocated the work of CR-1 on 17.01.2017 has vouched all available record received from the predecessor but could not found any reference to this dy. No. It is because of this reason only, the delay occurred in responding your RTI application. You may however like to provide a copy of your petition, duly complying with Rule 8 of RTI Rule 2012 for enabling the CPIO to register the case. So as to avoid further delay in the registration.
2	168047/16.10.2015	As per computerized Dak Management System, on this Dy. No., a file no. CIC/SB/C/2015/900604 has already been registered.
3	167847/15.10.2015	As per computerized Dak Management System, on this Dy. No., a file no. CIC/SB/A/2015/900132 has already been registered.
4	150566/29.07.2015	As per computerized Dak Management System of this Commission a Defect Memo dated 23.09.2015, copy enclosed for ready reference, has been sent to you.

Point No. 2: When a hard copy of the case filed online/offline is received in the Commission, it is duly diarized.

After diarization of the case, it is duly scrutinized. If everything is found OK, then file no. would be generated. Otherwise a Facilitation Memo (earlier known as Defect Memo) would be generated, duly high- lighting the deficiencies to be rectified by the appellant/complainant.

After registration/generation of file no., E-Book is prepared and it is uploaded on the software of the Commission (APPCOMS) for down-loading by the sub-registry of concerned Hon'ble CIC and listing the matter for hearing before Hon'ble CIC.

Delay in responding due to reasons enumerated against Dy. No. 168761/20.10.2015 is highly regretted.
