The CPIO (RTI Cell) has been mention that **point no. 2 & 10** is concerned to undersigned CPIO. The point-wise reply on it is as follows:-

Point No. 2

In the first instance, it is stated that it is absolutely unfair to say that undersigned in the capacity of Deputy Registrar (CR) has rejected the appeal/compliant. As per the existing procedure (available in public domain, one such link on the website of this Commission is – www.cic.gov.in/gaq#m3393) mandatory requirement for registration of a compliant is RTI application and (available in public domain Rule 8 of RTI Rules 2012; also at www.cic.gov.in/faq#n3393) mandatory requirement for registration of a second appeal is:-

- (i) Copy of RTI Application.
- (ii) CPIO reply, if any.
- (iii) Copy of First Appeal.
- (iv) Copy of First Appellate order, if any.

In addition to the above, in case of second appeal, it is desired that it may be filed as per Appendix to Rule 8 of RTI Rules 2012 & though there is no formal for compliant, but a format compliant letter addressed to the Commission is desired.

As far as signature of the undersigned is concerned, it may be appreciated that during a day on regular basis, in addition to other work, almost one hundred Facilitaion Memos are issued after scrutiny, as such due to huge rush of work, it is not possible to mark complete signature on them.

Point No. 10:-

It is a mandatory requirement. In this regard refer to Rule 8 of RTI Rules 2012 & link www.cic.gov.in/faq#n3383 (described in detail herein above).
