I am directed to refer to your application dated 5th July, 2016 regarding request for engagement as Consultant in Central Information Commission after retirement on 31.03.2015 from Intelligence Bureau, Ministry of Home Affairs, New Delhi. The Central Information Commission is pleased to engage you as Consultant on contractual basis initially for a period of three months from the date of joining up to 31.12.2016 or till a regular incumbent join or the Commission desires your services, whichever is earlier. If he is required to travel outside Delhi in connection with the work of the Commission during the period of his engagement, he will be entitled to draw TA/DA as per normal rules as applicable to any serving officer on an equivalent rank in the Commission.
