Point No. 2: Please refer to Shri Krishan Avtar Talwar, Deputy Secretary & CPIO(Central Registry-1) letter dated 03.04.2018 and further letter dated 06.04.2018 of Shri S.S.Rohilla, DR & CPIO, Registry of IC(SB), copies enclosed. Further to above it is to inform that file No. CIC/BS/A/2016/000639, has already been disposed vide CIC order dated 24.05.2017, copy enclosed.
