Sub: Providing of information under RTI Act. 2005.

Sir,

I am to refer to your RTI dated 23.04.2018 which has been registered vide no. CICOM/R/2018/00471. It has been received through online RTI MIS in Central Registry on 08.05.2018 with the request to provide you requisite information on point (b) of said RTI application.

For providing you the requisite information, assistance was sought from the custodian of the information ie I/C (Dak). The reply dated 09.05.2018 received by her is enclosed herewith. On its basis status of said Dy. No. is indicated below:-

- 1) Dy. No. **166137 dated 19.09.2017**, software of the Commission reflects that it was registered vide File No. CIC/MHOME/A/2017/166137 on **20.09.2017**. It will be listed for hearing in due course of time.
- 2) Software of the Commission reflects transfers of Dy. No. **166138 dated 19.09.2017** to Central Registry. But the same was not found traceable. After vigorous effects, it found attached with Dy. No. **166137** referred above. Dy. No. **166138** has since been delinked and on it a second appeal vide no. CIC/MOHOME/A/2018/166138 has been registered now on 16.05.2018. It would be listed for hearing in due course to time. Inconvenience caused in this regard is regretted.
- 3) Dy. No. **117569 dated 20.03.2018**, Computerized Dak Management System of the Commission reflects that it was registered vide File No. CIC/MHOME/A/2018/117569 on **20.03.2018**. It will be listed for hearing in due course of time.

As per the advice in letter dated 09.05.2018 *ibid*; pdf of above file (no. CIC/MHOME/A/2018/117569) was checked. It has been found that both of your letters dated 10.03.2018 and 11.03.2018 (both not having any enclosures) were annexed with it. Since already a Second Appeal no. CIC/MHOME/A/2018/117569 dated 12.03.2018 is registered. As such no action seems to be taken on these two letters.
