

Reference letter No. CICOM/R/2018/00768 dated 6.08.018. Point-wise reply to the questionnaire of the appellant is given below:

- 1 to 8 and 27 The complaints submitted by the RTI complainant have been received in the office of IC(YA). Taking cognizance of the allegations leveled against the staff posted with Hon'ble IC(YA) an inquiry has been ordered by the Hon'ble Information Commissioner (YA). The Registrar of the Commission has been detailed as the Inquiry Officer. As such the information sought by the applicant is exempted from disclosure u/s 8(1)(h) as the same may hamper the process of investigation.
- 9 to 11 All the parties to the dispute pending before the Commission are heard by the Hon'ble Central Information Commissioners as per the scheduled hearing. Apart from such scheduled hearing in the court room, any person of the adverse parties/litigants are discouraged to meet the Commissioner in person in their chambers.
- 12 As per the individual agreement of the respective Legal Consultant/Legal Retainer
- 13 to 15 No such information is available on record.
- 16 to 18 No information has been sought. This is rather in the nature of seeking opinion from the PIO. However it is to clarify that as per the decision of Supreme Court in Kushal Bhai Ratanbhai Rohit and others vs State of Gujarat SLP CRL453 of 2014 – a draft decision by an authority can be amended till the time it is finally signed and sealed.
- 19-20 No such information is readily available on record. Answering to such queries will amount to generation of information which is beyond the scope of RTI Act, 2005.
- 21 04.05.2018
- 22 No such reason is recorded on the file. However, it is the prerogative of the Commission to take time for finalization of order after hearing and reserving for order. There is no delay recorded on the files.
- 23 to 26 No such information is available on record.
