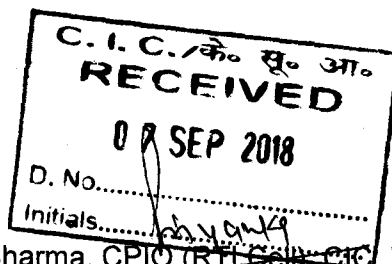
Perusal of your RTI application and the software reveals that First Appellate Authority had given his decision on your First Appeal on 21.03.2018 accordingly your Second Appeal dated 04.07.2018 diarized in the Commission on 17.08.2018 as per the provisions of RTI Act 2005 was held to be time barred and returned to you for resubmitting with request for condonation of delay vide Facilitation Memo No. 144793/2018 dated 23.07.2018.
