



With reference to your letter no. CICOM/R/2018/00970/CR-1, dated 08/10/2018, It is intimated that, as per Computerized Dak Management System the desired information as asked for in the RTI application of Shri K K Garg is as follows.

Perusal of software of the Commission dose not reveal receipt of any communication dated 06-02-2016. Further no record on the basis of Speed Post / Registered Post / Courier tracking no. is maintained.

However, the software of the Commission reflects receipt of a communication on 12-02-2016 (though its letter date is also being mentioned as 12-02-2016).
