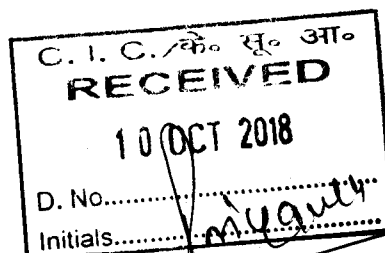

Perusal of software of the Commission does not reveal receipt of any communication dated 06-02-2016. Further no record on the basis of Speed Post / Registered Post / Courier tracking no. is maintained.
