
**Reply to your above RTI is as follows:-**

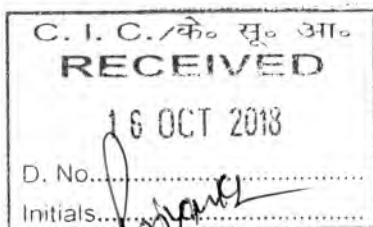
