I am to refer to your RTI application dated 28.11.2018 received from CPIO (RTI Cell) vide no. CICOM/R/2018/01188/1 on 18.12.2018 in CR II with the request to provide requisite information against point 3 and 4. The same is accordingly given below.

3. As per the data maintained, Commission has imposed penalty in total number of **1584 cases (for the period from 2006 to 20.12.2018)**. It is stated that no record relating to compensation awarded/ disciplinary action recommended by the Commission is maintained centrally at one place. As such, information relating to number of such cases, wherein compensation awarded or disciplinary action recommended etc, as asked for is not available. Whatever record is maintained, is maintained in that specific file in which the Commission awarded compensation or disciplinary action recommended.
