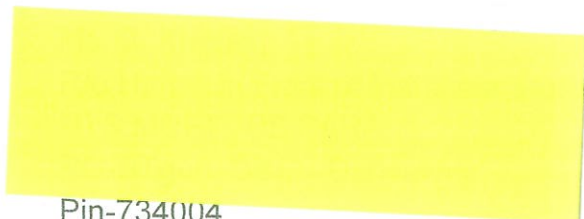

Issue no. 1

Assistance was sought from the Incharge (Dak Section), custodian of the information who has intimated that your petition dated **31.07.2018** was diarized vide Dy. No. 154356 dated 08.04.2017. Computerized Dak Management System of the Commission reflects that it was registered vide File No. CIC/NFRLG/A/2017/154356 on **08.08.2018**. It will be listed for hearing in due course of time.

Issue no. 2

Undersigned issued the Facilitaion Memo (Dy. No. 601039) dated 26.04.2017. Qualification is a personal information and exempted from disclosure u/s 8 (i) (j) of RTI Act, 2005 (available in public domain). In this context reference may also be had of Hon'ble Supreme Court judgment in the matter Canara Bank vs C.S. Shyam dated 31.08.2017 (available in public domain). Further no information as asked for regarding punitive action exists, as such cannot be provided.
