Point No. 1 & 4:-

The Registrar, custodian of the case file vide his communication dated 23.03.2018 (copy alongwith enclosures attached herewith for ready reference) had earlier informed that the concerned case file (File No. CIC/MP/C/2015/000044) is sent to the Record Room as the matter has already been disposed off by the Commission.

Incidentally, same type of information was sought by another appellant. In that case the aforementioned file was requisitioned from the Record Room. The staff posted in the record Room vide his email dated 06.04.2018 (copy enclosed for ready reference) has commented that "*as per available Record this file no. CIC/MP/C/2015/000044 is not available physically or electronically in the Record Room*". As such, in the absence of the record, no information can be provided.
