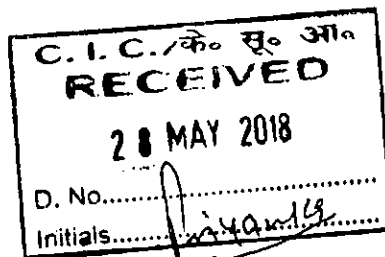
Sir,


