I am to refer to your communication dated **21.08.2018** on the subject mentioned above and to state that the appellant Shri Sanjay Kumar Gupta in his RTI application registered vide Registration No. CICOM/R/2018/50620 dated **13.8.2018** has sought information on 4 issues enumerated therein while referring about an e-mail dated **7.1.2018** and about a Dy. No.**606077**.

As far as Dy. No.606077/2017 is concerned, on it a facilitation memo dated 28.12.2017 was issued to the appellant by the undersigned with the remarks "the Commission does not have any Appellate or supervisory jurisdiction over the State Information Commission" merely because the appellant therein had sought information about Apollo Hospitals Group, Regd. Off. 19 Bishop Gardens, Raja Annamalaipuram, Chennai-600028 and Apollo Hospital, Bilaspur, Seepat Road, Lingiyadih Village, Bilaspur (C.G.) 495006 which even as on date is not appearing in the list of public authorities as available on the home page of website of this Commission; as such it was rightly held that said authorities do not come under the jurisdiction of this Commission. Incidentally, the CPIO and the FAA of Central Government also in their respective replies held that matter pertains to State Government.

The point No.9 on which you have preferred to seek information from the undersigned CPIO u/s 5(4) is rather appearing under the heading: SOME DETAILS OF ABOVEMENTIONED EMAIL CORRESPONDENCES". As such said point No.9 seems to be a reference document which the appellant is referring to.

Last but not the least, the email dated 07.01.2018 referred therein has been addressed to "CIC Administrator feedback-cic@gov.in" which has not been received in CR-1, CR-II and Dak Section. Under these circumstances, undersigned CPIO has no comment to furnish.
