- The Central Information Commission under Section 18(2) of the RTI Act, 2005 is empowered to conduct an enquiry if it is satisfied that there are reasonable grounds to enquire into the matter.
- The Commission shall, u/s 18(3) of the RTI Act, while enquiring into any matter, have the same powers as are vested in a Civil Court while trying a suit under the Code of Civil Procedure 1908 in respect of the following matters, namely:
 - (a) Summoning and enforcing the attendance of persons and compel them to give oral or written evidence on oath and to produce the documents or things;
 - (b) Requiring the discovery and inspection of documents;
 - (c) Receiving evidence on affidavit;
 - (d) Requisitioning any public record or copies thereof from any court or office;
 - (e) Issuing summons for examination of witnesses or documents; and
 - (f) Any other matter which may be prescribed

In W.P. (C) No. 12714/20096, titled as Delhi Development Authority vs. Central Information Commission & Anr., a Division Bench of Hon'ble High Court of Delhi comprising of Badar Durrez Ahmed J. and Veena Birbal J. vide its Judgment dated 21.05.2010 had set aside the Order dated 22/09/2009 pronounced by the Commission to the extent that the Central Information Commission appointed an 'enquiry committee' when it was incumbent upon the Commission to conduct the enquiry itself. The Hon'ble Division Bench has also quashed the Central Information Commission (Management) Regulations, 2007 as being ultra-vires the Right to Information Act, 2005.

It is not clarified under this Section as to what formats are to be used for summoning and enforcing the attendance of persons to give oral or written evidence on oath and/or to produce the documents. Therefore, in order to follow a uniform procedure for conducting the enquiry u/s 18 of the RTI Act, 2005, the draft formats for summoning and enforcing the attendance of persons along with records and also the discovery and inspection of documents before the Commission and draft warrant of arrest have been prepared on the basis of the draft of Summons available in Civil Procedure Code 1908 by making necessary modifications as per requirement of the Commission. Draft of Summons available in the CPC are placed at Flag 'A' and the draft Summons prepared to be used in the Commission are placed at Flag 'B'.
