Sir,

- 1. With reference to your letter no. CICOM/R/2018/51016/CR-I dated 03-01-2019, it is stated the letter dated 06-12-2018 was diarized vide Dairy No.172775 dated 18-12-2018 and the same has been returned to the sender to remove the deficiencies vide facilitation memo dated 19-12-2018. It is further stated that aforesaid letter was dispatched to Shri A Subramanyam Reddy , Plot no. 184, 6th Cross , Kessavayanagunta , Tirupathi -517501 Andhra Pradesh vide Speed Post Tracking No. ED919632675IN dated 26-12-2018.
- 2. With regards to point no. 13, it is stated that the 2nd Appeals/Complaints/letters etc. are received in Central Information Commission through various modes of correspondence such as ordinary post, registered / speed post / online etc. and after diarization these letters are sent to concerned registry of the Hon'ble CCIC/ICs as per work allocation. Some of the appeals / complaints which are deficient of the requisite mandatory documents are returned to the senders to complete the deficiencies.
- 3. Confidential/personal communication addressed to Chief Central Information Commissioner/ Information Commissioners are sent to the dignitaries concerned. After perusal, the dignitaries sent these letters/communication to the concerned office/registry for appropriate action. As such, though such appeal/complaint/letters etc. addressed to Hon'ble Cental Chief Information Commissioner and initially sent to him but subseprently charged in Dak record as these were marked to different officer/section/registry. Therefore the revised record cannot depicit the No. of letters etc. handed over to Chief Central Information Commissioner (as it now depicit the letter etc. though addressed to Chief Central Information Commissioner and initially sent to him but subsequently charged/marked to separate officer/section/registry). Furthermore non-cofidential/non-personal letters etc., though might have been addressed to Chief Central Information Commissioner but are opened and sent to concerned section/registry/officer for appropriate action at the Dak level staff.

As such, the desired information cannot be provided because sagrigating it would definitely divert the resources of the Commission.
