AGENDA: Section 24 of the RTI Act: Act not to apply to certain organizations.

It has been observed that Section 24 of the RTI Act has not clarified how to deal with the cases sent to the Commission pertaining to the allegation of violation of Human Rights by the exempted Public Authorities under the said Section.

Section 24(1) of the RTI Act reads as under:

"Nothing contained in this Act shall apply to the intelligence and security organizations specified in the Second Schedule, being organizations established by the Central Government or any information furnished by such organizations to that Government:

Provided that the information pertaining to the allegations of corruption and human rights violations shall not be excluded under this sub-section:

Provided further that in the case of information sought for is in respect of allegations of violation of human rights, the information shall only be provided after the approval of the Central Information Commission, and notwithstanding anything contained in Section 7, such information shall be provided within forty-five days from the date of the receipt of request."

The above mentioned proviso is apparently applicable to the Central Public Information Officer in case he wants to furnish the information sought for, as requested by the Applicant in his RTI application in respect of allegation of violation of Human Rights.

Further, it appears that if the CPIO is of the view that the information sought for should not be provided, the Applicant has a mechanism available for seeking the information by way of filing an Appeal/Complaint before the Central Information Commission.

The matter is placed before the Commission for consideration.
