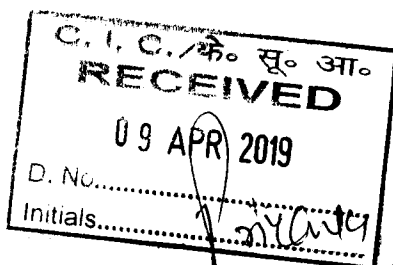


Sub: Assistance u/s 5(4) of the RTI Act, 2005 - reg.
