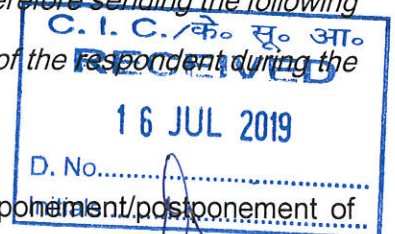
I am refer to the RTI application dated 17-06-2019 received from RTI Cell on 25-06-2019. The reply/information is as under:-

While forwarding the RTI application Registration Number CICOM/R/2019/00488/2 dated 25.6.2019, RTI Cell has advised the undersigned CPIO to reply Point Nos.1 & 4. The reply to Point 1 and 4 is as follows:

Reply to 1:

These emails dated 9.4.2019 were never received in the Registry of IC(SC). Therefore, the CPIO of this registry cannot answer about these emails. However, it is pertinent to mention here that applicant sent a detailed written submission dated 18.4.2019 (Dy.No.119210/26.4.2019), received in this Registry on 28.4.2019 on Appscom and was approved on the same day. It became part of E-Book after approval and this E-Book was before the Hon'ble Commission on 30.4.2019, the day of hearing. In this letter dated 18.4.2019 he, inter alia, stated that *"I will not be in a position to attend the hearing on that particular date. I am therefore sending the following points which may kindly be viewed as relevant to counter the pleas of the respondent during the proceeding of the hearing."*

In this letter dated 18.4.2019, the appellant did not seek any preponement/postponement of hearing but urged the Commission to view his written submissions on 30.4.2019, the day of hearing.

Reply to 3 (ii) & iv):


