With reference to your file No.CICOM/R/2019/00535 dated 16-07-2019, it is stated that the status of the Paras 1 & 2 of RTI application dated 01-07-2019 of Shri Prakashchand Chhaganmalji Jain is as under:-

<u>Para No. 1</u>. As per software of the Commission, application dated 26-06-2019 of Shri Prakashchand Chhaganmalji Jain was diarised vide Dy No. 131540 dated 02-07-2019 and as on date it is under submission.

<u>Para No. 2.</u> The complaint case diarized vide diary No. 117769/2019 has been registered vide file No. CIC/CICOM/C/2019/117769 by Central Registry . Already file no. CIC/CICOM/C/2019/117769 has been communicated to the appellant vide letter No. CCOM/R/2019/00344 dated 02-05-2019. It appears that the appellant is in confusion and thinking that registration No and file No are two different things, which in reality is not the case.

In order to make the things further clear from the prospective of the appellant it is sated that in response to communication dated 04-01-2019 (Dy.No.101131) and 12-04-2019 (Dy.No.117769), the information was provided by I/C (Dak Section) & DR to CR-I vide letters dated 14-02-2019 and 02-05-2019 respetively based on the information available in software of the Commission on the date of reply.

It is factually correct that Dy No. 101131 was not registered till 14-02-2019 as intimated vide this commission letter No. CICOM/R/2019/00123/CR-1 dated 14-02-2019. In this connection, it is also stated that the complaint case Dy. No. 101131 was sent to DO to Hon'ble CIC (DP) as it was addressed by name to the IC (DP) on 08-01-2019. Subsequently, upon forwarding of said dak (Dy.no. 101131/2019) by Sh. Haro Prasad. Sen, DR to CIC (DP) on 20-02-2019 to CR-I, the complaint case Dy. No. 101131 was registered and given File no. CIC/CICOM/C/2019/101131 on 27-02- 2019.

Similarly on complaint case dated 12-04-2019 (Dy.No. 117769) was generated file no. CIC/CICOM/C/2019/117769 on 02-05-2019 and information towards both the complaints was provided vide this Commission letter dated 02-05-2019. As such, there was no mistake on the part of undersigned & the part of DR to CR-I.
