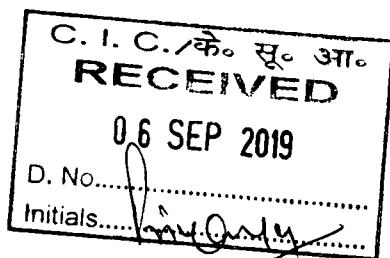

3. As mentioned in the noting referred against point No. 1, next date of hearing has not been fixed yet in the given case.

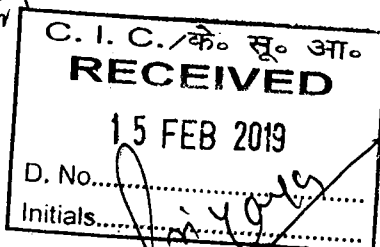
