ORDER

1. The appellant submitted RTI application dated January 16, 2014 before the Central Public Information Officer (CPIO), State Bank of India, Raibareilly seeking certified copies of form II submitted by Smt. Gulabkali Devi holder of account No. 11727579921 for not having married again after her husband's demise from 2002 to 2012 etc.

2. Vide letter dated March 3, 2014, the CPIO denied the information sought by the appellant stating that information sought by the appellant pertained to third party and was of commercial confidence u/s 8(1)(d) & (j) of the RTI Act, 2005. Not satisfied with reply given by the CPIO concerned, the appellant preferred an appeal dated March 3, 2014 to the first appellate authority (FAA). The FAA vide order dated April 1, 2014 upheld the decision of the CPIO.

Dissatisfied with the public authority, the appellant preferred the present appeal before the Commission.

4. The matter was heard by the Commission. The appellant stated that he had sought information with respect to Smt. Gulabkali Devi who was allegedly submitting false declaration to the bank authorities even after she was remarried and was taking benefit for the last 10 years but the same was denied

to him. He stated that he had enclosed the documents which proved that Smt. Gulabkali Devi had been married. The respondents stated that the information sought by the appellant was not provided to the appellant u/s 8(1)(d) & (j) of the RTI Act, 2005 because of commercial confidence and as the information was related to a third party, their customer and thus also held by them in fiduciary capacity. The appellant basically had a complaint regarding Smt. Gulabkali Devi drawing pension even after her marriage.

5. The Commission recommends that the respondents will send the case of Smt. Gulabkali Devi to pension disbursing authority with complete documents received from the appellant for taking requisite action as deemed fit in the matter within a week of the receipt of the order of the Commission under intimation to the Commission. The appeal is disposed of.
