3 (a),(b) & 4 No centralized record of 'Compensation' is maintained. Each such order is placed in the concerned file by the respective registries. As such, as per section 7(9), the requisite information cannot be provided to the appellant.

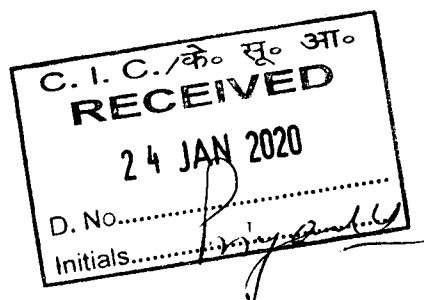
