Sub: Providing information under RTI Act., 2005.

Sir,

I am to refer to your online RTI application dated 03.03.2020. It has been registered vide no. CICOM/R/E/20/00165. It has been received through online RTI MIS in Central Registry on 04.03.2020. The information is as under:-

1. Petsual of your RTI application does not reveal the specific issue on which information is being sought. However, it appears that you are perhaps seeking status of your second appeal/complaint filed online vide Dy. No. 601318/2020 on 13.01.2020, if that is the case, then it is stated that due to some technical glitch, said dy. No. was not available for scrutiny.

On receipt of your aforementioned RTI application, the matter was taken up with the technical team and they provided said Dy. No. on 05.03.2020. After scrutiny, it has been observed that the PIO, Ministry of Personnel, Public Grievances and Pensions, Department of Adminisitrative Reforms and Public Grievanves vide his communication dated 06.09.2019 transferred the RTI application to a public authority under the jurisdiction of Government of Punjab. Accordingly, said appeal/complaint has been transferred to the Secretary, Punjab State Information Commission vide Facilitation Memo (Dy. No. 601318/2020) dated 05.03.2020 through Speed Post Trackig No. ED970900164IN dated 06.03.2020 under intimation to you.

2. Further, you have mentioned about your another Second Appeal/Complaint filed online with Diary No. 658663/2019. Perusal of software of the Commission reveals that it was transferred by this Commission on 08.01.2020 to Punjab State Information Commission under intimate to you as the US, Ministry of Personnel, Public Grievances and Pensions, Department of Administrative reforms and Public Grivances forwarded your RTI application No. DARPG/E/2016/50725 dated 29.08.2019 to Additional Chief Secretary, Removal of Grievances which appeared to be under Punjab Government.

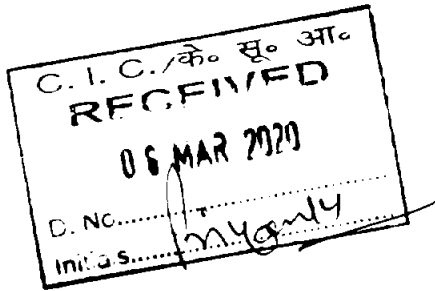
