Therefore the averment made by the appellant to the effect that "email communication dated 26.02.2021 @ 01:37 PM not replied" until filing this RTI application; in the 'subject matter of information is factually incorrect.

3. The scrutiny of Second Appeal/Complaints received in this Commission is done by a team headed by the undersigned. Record relating to which Diary No. attended to by which team member is not maintained. Even otherwise, it is the undersigned who in his official capacity signed the Facilitation Memo and take the full onus for it. Issuing of this Facilitation Memo was even communicated to the appellant by the undersigned vide his email response dated 01.03.2021 as referred in issue No. 2 here in above.

Therefore asking same information time & time is nothing but putting undue pressure on dedicated Govt. Servent, undersinged is a most unwarranted act. And thus may please not be repeated.

4. The appellant is requested to refrain from using such derogatory language. Further the appellant is also requested to desist from mentally harassing the undersigned CPIO who is banafidely discharging his official duties, by sending multiple emails, on the same subject, full of derogatory remarks. He has filed RTI application, then he must wait for the stipulated period, provided under the RTI Act-2005 to allow the undersingned CPIO to attend to his RTI application in addition to attending to his other official duties. The requested information is duly reflecting in the email response dated 01.03.2021 and reproduced against issue No.2 and narrated in issue No. 3 herein above.

As far as issue relates to no-mentioning of name on the Facilitation Memo is concerned, it is clarified that Facilitation Memo are issued from software of the system. Rather undersigned CPIO cum Deputy Secretary was not posted in Central Registry when this software was developed. Perhaps this provision was made to avoid chages in software due to change of incumbent. You may appreciate that under 'contact us' on web-site of this Commission name of all officers are mentioned therein.

5. No specific information sought.
