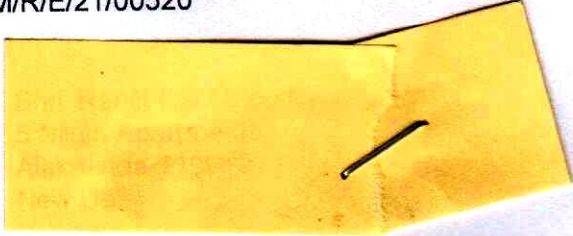

Sub: Seeking information under RTI Act., 2005.

Sir,

I am to refer to online RTI application of Shri Ranjit Rai Grover, which has been registered vide No. CICOM/R/P/21/00520. It has been received through online RTI-MIS from RTI-Cell on 10-06-2021 with a request to provide information sought for by the applicant. The reply of RTI application referred to above is as under:-

Point 1&2. Software of the Commission does not reflect receipt of Appeal against CPIO/FAA, Post Offices, Delhi Circle, RT/CR-8/JAN-11/2029-20 dt.30-06-2020. However, Software of the Commission reveals that a second appeal dated 30-06-2020 against the order of the CPIO/FAA, Post offices, Delhi Circle RT/CR-8/JAN-11/2019-20 Dated 4.2.20 was received which was duly diarised vide diary no. 117798 on 02-07-2020. A second appeal on it was admitted vide file no. CIC/POSTS/A/2020/117798 on 03-07-2020. It will be listed for hearing in due course of time.

It seems the appellant is referring to Facilitation Memo dated 03-07-2020 issued on diary no. 117797/2020 dated 03-07-2020. As per software of the Commission the resubmitted second appeal dated 30-07-2020 of Shri R R Grover against Delhi Jal Board was diarised vide diary no. 122085 on 06-08-2020 and a second appeal has been admitted vide file no. CIC/DELJB/A/2020/122085 on 10-08-2020 on it. It will be listed for hearing in due course to time.

Point 3&4. For seeking information related to email sent to id : helptrionline-dopt@nic.in, you may like to approach appropriate authority directly.
