Point No.B No such time limit prescribed/available on record.

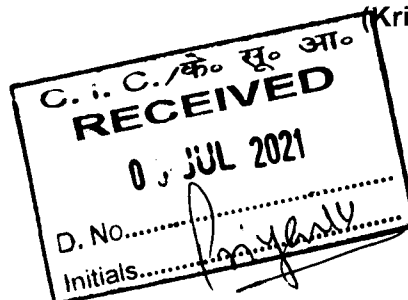
