A 'senior citizen' would mean one who has attained the age of 65 years as on the date of making the application and a 'physically challenged person' means a person suffering from not less than 40% of any disability as certified by a medical authority under Disabilities (Equal Opportunities, Protection of Rights and Full Participation) Act, 1995.
