With reference to your letter no. CICOM/R/P/22/00145-CR-1 dated 03-04-2022, it is stated that the status of Point 3 (b) (i) RTI application dated 11-03-2022 of Shri Krishna Kumar Mishra is as under:-

- (a) At the outset, it is stated that status of second appeal/complaint is searched based on the name of the appellant/sender in the software of the Commission (Appscoms & e-Office). The appellant has not mentioned complete date in respect of second appeal/complaint dated 28/8/.... As the appellant is referring in his query about his second appeals/complaints pertaining to last year as such, it is held that perhaps the appellant is referring to second appeal/complaint dated 28-08-2021. If that is the cae, it is stated that perusal of software of the Commission does not reflect receipt of any second appeal/complaint dated 28-08-2021 of appellant/sender (with possible name combinations , i.e. Krishna Kumar Mishra, Krishan Kumar Mishra & K K Mishra).
- (b) As per software of the commission, two second appeals/complaints dated 18-02-2021 of Shri Krishna Kumar Mishra were diarized vide diary no. 109107 & 109108 both dated 26-02-2021 and both the second appeals have been registered vide File No. CIC/DOATE/A/2021/109107 and CIC/DOATE/A/2021/109107 on 26-02-2021 respectively. - (c) As per software of the commission, second appeal/complaint dated 31-01-2021 of Shri Krishna Kumar Mishra was diarized vide diary no. 108102 dated 22-02-2021 and the Appeal has been registered vide File No. CIC/DOATE/C/2021/108102. It will be listed for hearing in due course of time.
- (d) In repect of other communications/second appeals/complaints received from Shri Krishna Kumar Mishra during last year 2021, printout of dak status taken from the system of the Commission is enclosed herewith. The second appeal/complaint dated 12-06-2021 of the appellant diarised vide Dy No. 124290 dated 25-06-2021 was returned to the appellant/sender for removal of deficiencies. Against communication/appeals/complaints diary Nos. 135572 dated 03-09-2021 and 139885 dated 22-09-2021, second appeals/complaints have been registered and these will be listed for hearing in due course of time.
