2. Information as available with concerned agency of this Headquarters and permissible under RTI act 2005 is given as under :-

(a) **Query No 1.** It is confirmed that Director Military Farm Headquarter Eastern Command issued termination orders in respect of Shri Bharat Chaubey vide letter Number 350318/2/E/Farms dt 05 Mar 1998 (copy attached).

(b) **Query No 2.** Only appointing authority can terminate the services. In this case appointing authority i.e. Director Military Farm Eastern Command issued termination orders.


