
Having not received any information from the CPIO, the Appellant filed a **First Appeal** dated 23.11.2020. The First Appellate Authority vide order dated 16.12.2020, upheld the CPIO's replay as under:

In view of the aforesaid anomaly, the Commission is of opinion that no such reply has ever been given to the Appellant and accordingly directs the Respondent to provide a categorical reply to the Appellant qua the instant RTI Application strictly as per the provisions of the RTI Act, within 30 days from the date of receipt of this order.

With the above observations, the instant Second Appeal is disposed of.

The Appeal, hereby, stands disposed of.





The undersigned being the Appellate Authority has considered the appeal dated 23/11/2020 preferred by Sh. Jatinder Singh against information provided by the CPIO.

The Appellate Authority perused the relevant records and came to the conclusion that the CPIO had provided the information on the said RTI application dated 03/12/2020 mentioned above under the provisions of the RTI Act, 2005. The information provided by the CPIO is just and fair.

Accordingly, the information provided by the CPIO is upheld and the appeal dated 23/11/2020 of Sh. Jatinder Singh is disposed off.

Grounds for Second Appeal:

The Appellant filed a Second Appeal u/s 19 of the Act on the ground of unsatisfactory reply furnished by the Respondent. Appellant requested the Commission to direct the CPIO to provide complete information sought for.

Submissions made by Appellant and Respondent during Hearing:

The Appellant stated that he has not received any reply from the Respondent qua the instant RTI Application.

The Respondent submitted that the then CPIO has provided a reply to the Appellant vide letter dated 03.12.2020 but the same is not available in their record file.

Decision:

Upon perusal of the facts on record as well as on the basis of the proceedings during the hearing, the Commission observes that the reply provided by the then CPIO vide letter dated 03.12.2020 has not been received by the Appellant and is not available in the record file of the Respondent without which the Commission is unable to decipher what information has been given qua the instant RTI Application. Thus the Commission admonishes the Respondent for poor management of the official records and cautions them to remain careful in future.
